- Activity Period: June 22, 2026 (Mon) – July 31, 2026 (Fri)
- Final Report Submission: By August 7, 2026 (Fri)
(Final report, satisfaction survey, 1 short-form video, and 10 photos required)

4 Eligibility

- An international undergraduate student for the Spring 2026 semester
- Each team must consist of at least 4 members
- * **All selected participants are required to purchase travel insurance**
- * **Attendance at the pre-program orientation is mandatory for all team members**
